

Beginning January 1, 2016, Tri-State Generation and Transmission Association, Inc. (Tri-State), our member owned

power supplier, will return to a traditional wholesale rate. This will impact both the purchased power rate structures for Carbon and for you the Member-Owner. Below is an excerpt from Carbon's letter of notification from Tri-State about the 2016 rate change. Carbon is a Class A Member.

"The Board concluded that the Class A Rate average rate will decrease on an annualized basis from 7.353¢ per kWh under Rate Schedule A-38 to 7.332¢ per kWh under Rate Schedule A-39. Tri-State will discontinue its seasonal average demand rates and implement two demand rates, a Generation Demand Rate and a Transmission/Delivery Demand Rate, both billed using the Tri-State Peak Period/Member Coincident Peak Billing Demand (TPP/MCP). The peak period is from 12:00 PM (noon) through 10:00 PM (the billing ½ hour period ending 12:30 PM through the billing ½

hour period ending at 10:00 PM) daily, Monday through Saturday, with the exception of the following six (6) holidays if occurring on Monday through Saturday: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day and Christmas Day. Tri-State will also move from the time-of-day on-peak and offpeak energy rates to a single energy rate under Rate Schedule A-39."

With this rate change, Carbon completed a Flow-Through Cost of Service (COS) review. A Flow-Through COS is used to determine the impact of the wholesale rate change on Carbon's rates to its Member-Owners. It simply looks only at the impact of the power supplier rate on Carbon's rates. This is the resulting proposed rates to our Member-Owners beginning January 1, 2016. See the 2016 Proposed Rates in the bottom left corner.

Since this is a flow-through rate adjustment, only the energy and demand rates are affected. You can calculate your increase or decrease just by using the appropriate energy and/or demand charges from an existing bill. Your billing information is also available online at carbonpower.com. Just click on E-BILL and register if you haven't already done so.

Generally the rate impact on a percentage basis is as follows: General Service (0.191%) decrease, Time-of-Day (6.38%) decrease, Irrigation 10.918% increase, Large Power (2.416%) decrease, Extra Large Power 20.145% increase and Outdoor Lighting (5.49%) decrease.

These percentages assume that usage patterns remain the same and some of the Large Power and Extra Large Power rate users will have opportunity to control their usage at certain times and achieve savings.

These rates and the COS have not been approved by Carbon Power & Light's Board of Directors and are subject to change.

I have been asked to rerun the article listed to the right that was published the end of 2014. The reason is due to the issues Carbon Power & Light Inc. is experiencing with the U.S. Postal Service and the timing of their deliveries. We continue to watch the postage dates on the envelopes we receive in our office to remove penalties on those Member/ Owners that pay by the due date listed on the monthly billing.





All Member/Owners can create an account in the E-bill program (instructions listed below). The advantage to creating an account in the E-bill program is that you will receive an email notice as soon as our billing is completed on the second working day of the month with the amount due and usage consumed and not have to wait for the bill to be delivered by the postal service. Should any Member/Owner have questions or concerns please feel free to contact Carbon's billing department.

Did you know that Carbon Power and Light (Carbon) offers our Member/ Owners many convenient payment options for their monthly billings?

We have the traditional, writing a check and sending in the mail or dropping off at our headquarters facility at 100 E Willow in Saratoga. Of course cash is always accepted in person.

Carbon also provides drop boxes at our headquarters building, Encampment Town Hall or Rock River at our shop facility at 405 Thompson. American National Bank (ANB), formally known as Capital West Bank, located at 3908 Grand Avenue in Laramie, will accept payments on our behalf for your electric bills. Rawlins National Bank (RNB) at 220 5th Street in Rawlins will also accept our payments similar to ANB. For the service at ANB

or RNB we request that you have your account number and/or billing stub with your payment.

Carbon also can take credit card and check payments via telephone at 800-359-0249 or 307-326-5206.

You can sign up for our electronic payment transfer program that will automatically debit your checking or savings account or credit/debit card on the 15th of each month. With this program you need to call us and paperwork will be sent to you authorizing Carbon to complete the transaction. For those Member/Owners who prefer the digital world Carbon also provides our E-Bill program which enables the Member/Owner to pay with credit cards and bank account debits. The Member/ Owner may sign into our website, @ www. carbonpower.com; then click on the E-Bill program located on the right sidebar of the web page. You will then need to register to use this program. You will be asked for your account number, name and/or business name, an email address and a password of 4 to 10 characters. Registering one billing account will display all of your accounts on the payment page should you have multiple accounts with Carbon. Once you have completed the initial registration, you can pay your monthly billings, monitor or compare previous monthly usage on your account(s) and/or request that no paper bill(s) be sent to you. If you request no monthly billing statement be sent, you can still see your bill in the E-Bill system. With this service you can also estimate what your billing might be should you decide to add a new appliance, heating system, etc. You can also see your capital credit history.

As technology evolves we will keep you up to date on these programs. All of Carbon's payment options are provided at no additional cost to our Member/Owners.

METERMAN CERTIFICATE AWARDED

Carbon Power & Light's Director of Operations David Cutbirth stated that Josh Saier worked through the Merchant Job Training and Safety Program to

obtain his Meterman's Certificate. Josh enrolled in the metering program in 2013 and received his certificate of completion in August of this year. The Merchant Program is a four-year curriculum consisting of 8,000 hours of on-the-job training but becasue Josh holds a Journeyman Lineman's Certificate he

was only required to complete 4,000 hours.

Mr. Cutbirth further stated that it is quite an accomplishment to complete the Meterman's program while holding a Journeyman Lineman's Certificate. Josh was awarded his certificate during the August board meeting.

"Mr. Saier maybe the first in the state to hold both certificates and possibly the first individual to complete the Meterman's program with the Department of Labor".
