PRESIDENT AND GENERAL MANAGER'S

JOINT REPORT

Laurie Forster



We are going to have our 79th and 80th annual meetings on the best Saturday in June; 6/26/2021.

We have a lot to review since we missed you, our outstanding Member-Owners, last year.

Virtual, Zoom and Teams are all types of meetings and gatherings you have when the world is under pandemic protocol. We are here to let you know none of them are optimal for your Cooperative. In the last year, we have completed countless waist up meetings and virtual discussions.

Our Audit was completed virtually for 2019-2020 and will be again for 2020-2021. Our 2019-2020 audit was clean and we will not get our 2021 Audit until after the meeting.

We distributed \$1,073,062 in capital credit checks last year and plan to distribute \$1,005,719 at the meeting this year.

Tri-State G&T along with all of Texas experienced challenges with reliability during the extreme cold during the middle of February. Tri-State had three cooperative members that had to shed load for the protection of the grid. The reliability of the grid must remain a priority as we move to a reduced carbon environment.

Due to the anticipated pandemic slowdown, we implemented a new service rebate program in 2020. The rebates totaled \$468,000. We completed 112 new services under the program. Our average annual new services since 2010 has been 60 and the last time we were over 100 new services was 2008. This achievement was not without challenges. Our engineering team was stretched thin and some material was very hard to come by. Our line crews met the challenge that comes with scheduling to meet our Member-Owner's needs. Hats off to all Carbon Employees that helped us make this effort a great success.





2019 MINUTES OF THE 78TH







2019

CALL TO ORDER:

Director Laurie Forster called the 78th annual meeting of the membership to order at 12:33 P.M. on June 22, 2019 at the Platte Valley Community Center located in Saratoga, WY. The Pledge of Allegiance was recited by those in attendance followed by a moment of silence for Peg Johnson, then the invocation was given by Director Jim Rogers.

WELCOME:

Director Laurie Forster welcomed the Membership and guests followed by introductions of the Board of Directors/spouses, Attorney and the General Manager.

OFFICIAL NOTICE OF QUORUM:

Corporate Attorney Hank Bailey reported that a quorum had been met by the Member-Owners present. Mr. Bailey reported that the minutes of the 77th Annual Meeting of the Membership, held June 23, 2018, was published in the June edition of the Carbon Light Lines. Mr. Bailey asked for a motion to approve the amended minutes of the June 23, 2018 minutes. A Member-Owner from the floor motioned to accept the minutes of the 2018 Annual Meeting of the Members as presented. The motion was seconded and approved by the Membership.

JOINT REPORT BY PRESIDENT LAURIE FORSTER AND GENERAL MANAGER RUSSELL WALDNER:

President Forster and Mr. Waldner asked the membership to review their report. Member-Owners were encouraged to read the cooperative's publications; the WREN and the Carbon Light Lines. These two publications are vital in keeping the members up-to-date on issues that affect the day to day operations of the Cooperative. Mr. Parrie completed a slide show that entailed pictures of Carbon projects past and future.

MEMBERSHIP MEETING

TREASURER'S REPORT:

Treasurer Daniel Hodgkiss reported on taxes paid by Carbon in 2018. Mr. Hodgkiss reported the annual audit would be taking place next week by Blodgett, Mickelsen & Adamson P.S. and that last year's audit results concluded no issues.

STUDENT CERTIFICATES:

Certificates were presented to the 2019-2020 Scholarship recipients. Carbon's recipients were Noelle Peterson, Kieran Neville, Mattie A Stevenson, Sam Schneider, Mychaela Jackman and Kyleigh A Bingham. Tri-State recipients were Tiffany Bauer and Sean Stewart. Basin recipient was Mychaela Jackman

EMPLOYEE/DIRECTOR SERVICE:

President Laurie Forster and Mr. Waldner presented certificates of service to the employees Trist Coffin and Matt Drake for 5 years of service, Bruce Manore for 20 years of service and David Cutbirth for 40 years of service. Mr. Waldner requested Mrs. Debbie Reichert to the stage and announced her retirement and thanked her for all the years of service. President Laurie Forster presented Director Kenny Curry for 10 years of service.

TRI-STATE REPORT:

Carbon's Board representative for Tri-State, Director Richard Clifton, gave an overview of WREA & Tri-State's operations over the past year. Director Clifton started off his report with three WREA points to discuss. Mr. Clifton reported there were two of Carbon's lineman interested in the International Program and they could be going to Bolivia. There is going to be a Cooperative Business class taught at the University of Wyoming that will help people understand what the cooperative business model is. It will be offered this fall. WREA has 13 kids from Wyoming in Washington DC right now at the Youth tour. Tri-State in CO is working hard with the Colorado Public Utility Commission who is trying to govern them, and Tri-State will comply. Mr. Clifton reported on the struggles that Tri-State is having with Guzman wanting to buy Tri-State's

assets and sell power back to Tri-State. Director Clifton introduced the new CEO of Tri-State, Mr. Duane Highley. Mr. Highley thanked Carbon Power for starting their meeting with the pledge and an invocation. Mr. Highley was excited when he found out that the Carbon Logo was the exact Willie Wirehand he had been looking for to represent the west. Mr. Highley was very impressed with all Carbon is doing for the Scholarships we offer. He himself was a recipient of a cooperative scholarship. Mr. Highley stated he would do his best to keep reliable and affordable energy for Carbon's members. Mr. Highley reported he will make sure the electricity Tri-State supplies Carbon is reliable with the changes to the grid and with its transition to more wind and solar power.

ELECTION RESULTS:

Attorney Hank Bailey reported that the Nominating Committee met in April to review the bylaws as they pertained to the process of nominating and electing Board Members. In April, the Chairman of those committees reported their recommendations as follows:

The 78th Annual Meeting of the Membership was adjourned at 1:46 P.M.





VOTING INSTRUCTIONS ~ 4 EASY STEPS DISTRICT 2 VOTING BALLOT

Attention Member-Owners

Members from District 2 will be the only district voting this year. Board of Directors for District 1 and 3 are running unopposed; therefore, Member-Owners within these two districts do not need to vote.

How do I know if I reside in District 2? You are a Member-Owner from District 2 if you receive electrical service in **Elk Mountain**, **Rock** River, Medicine Bow, McFadden or in Arlington.

Voting is a very important part of member participation in the democratic process of the Cooperative.

VOTING BY MAIL:

Mark your vote on the ballot below and place your ballot in the envelope marked "ballot envelope" and seal.

L-Place the ballot envelope in the postage paid reply envelope and seal. Both the ballot and business reply envelope are provided for you and are located in the middle of this magazine.

3-On the back of the Business Reply envelope, write your account number on the line provided. Your account number can be found on your bill at the top right hand corner second row. Then sign your name on the line provided and indicate your business title if applicable.

-Mail the Business Reply envelope. Ballots must be returned in the envelopes as described above in order to be valid. Ballots must be received by 4:30 P.M. on Friday, June 25, 2021. Please allow sufficient time for delivery.

VOTING BY ABSENTEE:

Should Members decide to vote by absentee. The ballot box will be the drop box (payment box) in Encampment and in Saratoga.

WHO CAN VOTE? Single Membership:

If a membership is single, not joint, only the Member whose name is on the account is registered and eligible to vote.

Joint Membership:

A joint membership with two or more names is entitled to only one vote. If one Member is away, the other can still vote.

Businesses, Churches, Schools or Other Organizations:

For memberships listed as businesses, churches, schools, or other organizations, only the authorized represenative may vote on the ballot.

Validity of Ballots:

Valid votes shall be only those timely and properly received as outlined in these instructions. Ballots mailed-in are not valid unless returned in the two enclosed envelopes provided in this Notice.




