RETIRES AFTER 34 YEARS OF SERVICE

Carbon Power & Light has been under the management of Russell "More Data" Waldner for the past 10 years, which makes him one of the more experienced managers. PRESIDENT AND MANAGER



Jim Rogers President

President
When you know your days are
numbered you start to reminisce. I
refuse to slide into my final day like
it is home plate and the throw will
be close. I'm going in full speed and
"look out" to anyone in my way.

I looked at the statistics for Carbon when I started and thought it would be a good comparison for my impact as an employee at Carbon. In July of 1991 we had \$16,600,964 in total utility plant, power cost \$252,378, expenses less power cost \$103,734, tax & interest paid \$51,159, interest on investments \$12,903, total meters 4,540 and residential meters 3,808, miles of line 1,672 and meters per mile 2.72, total kWh 5,969,720 and residential usage 2,063,479, the average residential usage 534 kWh and the average bill \$43.65 and we had an average investment per meter of \$3,656.59. The current stats for July 2024 are \$60,533,516 total utility plant, power cost of \$687,377, expenses less power cost \$598,435, taxes and interest paid \$75,249,

interest on investments \$25,525, total meters 6719, residential meters 5,542, miles of line 2,018 and meters per mile 3.3, total kWh 9,137,120 and residential usage 2,891,079, the average residential usage 522 kWh and the average bill \$94 and we had an average investment per meter of \$9,009.30.

When we talk with other cooperative employees we us these numbers to explain the size and makeup of our cooperative. This is the icebreaker conversation at cooperative events. "We have 6,719 meters and are mostly residential. Over 80 percent of our meters are only 32 percent of our load and our meter density is 3.3." A response may be, "Wow, that is a pretty low average residential monthly usage." And I always tell them we are a very conservative bunch. If the rest of the nation would follow our example we would have no need for a "green new deal."

I have been giving Joe Parrie a hard time about not increasing the average residential kWh usage, so he told me he was retiring first.

The Carbon Team stats while I was fortunate to be a member of the team. Increased total utility plant 2.65 times, increased power costs 1.72 times, increased expenses less power cost 4.77 times, 48 percent more total meters and 45.5 percent more residential meters, 21 percent more miles of line and the same increase in density, a 53 percent increase in total kWh and a 40 percent increase in residential kWh. The average residential usage is a negative 2 percent, while the bills

went up 1.15 times. Our investment in each service is a whopping 2.47 times more than when I started with the team.

After review and evaluation of the stats for 34 years I think Carbon was great when I started and Carbon is great as I depart. The things that make me proud are the human interactions that I have had with members. It is the people of Carbon that make it the best cooperative to be a team member of!

This is a joint report with the President but I took all the space so he will have to give his report verbally at the meeting.




My permanent residence in Centennial Wyoming and being a member of Carbon Power and Light

Inofficial minutes of the 83RD ANNUAL MEETING

2024 MINUTES OF THE 83RD!!







2024

Call to order:

Director Shae Johnson called the 83rd annual meeting of the membership to order at 12:35 p.m. on June 22, 2024 at the Platte Valley Community Center located in Saratoga, WY. The Pledge of Allegiance was recited by those in attendance and then Director Jim Rogers gave the invocation. A moment of silence for Dan Hodgkiss and Pat Eastman was taken.

Reading of the Official Notice:

Attorney Hank Bailey read the Official Notice of the 83rd Annual Meeting printed in the May edition of the cooperative's newsletter in the WREN magazine.

Official Notice of Quorum:

Attorney Hank Bailey reported that a quorum was present with registered Member-Owners.

2023 Minutes:

Attorney Hank Bailey asked for a motion to dispense with the reading of the minutes from the 2023 Annual Meeting of the Membership. A Member-Owner from the floor motioned to approve the minutes. The motion was seconded and approved without dissent.

Joint Report by President Jim Rogers and General Manager Russell Waldner:

President Rogers reported Carbon has the best employees and shared his appreciation for them. Mr. Waldner reported their written report was in the WREN and encouraged the membership to read it. Mr. Waldner reported that carbon is currently completing a cost of

service study and he is certain there will be a rate increase at the beginning of 2025.

Treasurers Report:

Treasurer Debbie Reichert reported on the taxes paid by Carbon in 2023. Mrs. Reichert reported the annual audit would be taking place in July by Blodgett, Mickelsen & Adamson P.S. and that last year's audit results concluded no issues.

Student Scholarships:

Scholarship certificates were presented to the 2024 scholarship recipients. Carbon's recipients were Marilee Williams and Mackenzie Priest were present. 
