

Starting the week of May 3, 2026, Carbon Power & Light will begin the 4-day work week through September 24, 2026. Hours will be Monday - Thursday 7 AM to 5:30 PM

Last month I mentioned that it was hard to believe that spring was already upon us. Currently, I find it even harder to believe that fire season has arrived so soon. We've already had to put our system on non-re-close due to the National Weather Service issuing a Red Flag Warning combined with extreme wind conditions in our service territory. When we are non-re-close, our breakers will only operate one time then lockout; typically, they operate four times before lock-out. We then must patrol the entire line before the protective device can be closed in to re-energize the line; this significantly increases outage times but is a necessary precaution during times of high fire danger. Albany County has already enacted partial fire restrictions and by the time this goes to press, Carbon County is likely to do the same. Along those lines, fire liability and wildfire mitigation are hot topics in the industry today. Here at Carbon, we have been putting in many hours developing a Wildfire Mitigation Plan that will be acceptable to the Wyoming Public Service Commission. The purpose of the plan is to describe how we will reduce the risk of electrical equipment ignited wildfires by addressing the features of both our system and our service territory. The Strategies and practices implemented include design & construction, inspection & maintenance, operational

practices, situational awareness and response & recovery. What this means for us is additional procedures and labor to meet the parameters of the plan. What this means for you is that you could see extended outages as we follow the plan, such as in the example above where our breakers operate less and we have to patrol more. Ultimately the goal of the plan is to keep everyone safe and to protect the Cooperative from liability, which also benefits you, the member.

Also last month I mentioned our annual meeting coming up on Saturday, June 27th with registration beginning at 10:30 a.m. followed by lunch, bingo, and the business meeting itself. The meeting will once again be held at the Platte Valley Community Center located at 210 W. Elm Ave in Saratoga. We continue to plan for the event and always strive to make it worth your while. For those of you that have been a member for 17 years or longer, your capital credit checks will be available for pickup. All registered members will be able to participate in board member elections for their districts. There are prizes for bingo, a delicious meal, valuable information regarding CP&L and attendance prizes during the meeting. Attendance prizes include beef packages and a chance to win \$1,500 cash. We hope to see you there!

ENERGY EFFICIENCY
TIP OF THE MONTH

As we prepare for the seasonal shift, remember to set your ceiling fan rotation accordingly. In winter months (or whenever your home heating system is running), fan blades should rotate clockwise, which produces an updraft that pushes warm air down. In summer months (or whenever your home cooling system is running), blades should rotate counterclockwise, which produces a downdraft or windchill effect that makes you feel cooler. When used correctly, ceiling fans can boost comfort and allow you to adjust the thermostat a few degrees for energy savings.
