





#### VOTING BY MAIL:

L-Mark your vote on the ballot below and place your ballot in the envelope marked "ballot envelope" and seal.

**Z**-Place the ballot envelope in the postage paid reply envelope and seal. Both the ballot and business reply envelope are provided for you and are located in the middle of this magazine.

**3**-On the back of the Business Reply envelope, write your account number on the line provided. Your account number can be found on your bill at the top right hand corner second row. Then sign your name on the line provided, print your name and indicate your business title if applicable.

4 -Mail the Business Reply envelope. Ballots must be returned in the envelopes as described above in order to be valid. Ballots must be recieved by 4:30 P.M. on Friday, June 23, 2023. Please allow sufficient time for delivery. VOTING BY ABSENTEE: Should Members decide to vote by absentee, the ballot box will be the drop box (payment box) in

Encampment, Saratoga and in Rock River. WHO CAN VOTE?

#### Single Membership:

If a membership is single, not joint, only the Member whose name is on the account is registered and eligible to vote.

#### Joint Membership:

A joint membership with two or more names is entitled to only one vote. If one Member is away, the other can still vote.

## Businesses, Churches, Schools or Other Organizations:

For memberships listed as businesses, churches, schools, or other organizations, only the authorized represenative may vote on the ballot.

#### Validity of Ballots:

Valid votes shall be only those timely and properly received as outlined in these instructions. Ballots mailed-in are not valid unless returned in the two enclosed envelopes provided in this Notice.

#### Call to order:

The Pledge of Allegiance was recited by those in attendance followed by a moment of silence for those we have lost, then the invocation was given by President Jim Rogers.

#### **Reading of the Official Notice:**

Attorney Hank Bailey read the Official Notice of the 81<sup>st</sup> Annual Meeting printed in the May edition of the cooperative's newsletter in the WREN magazine.

#### **Official Notice of Quorum:**

Attorney Hank Bailey reported that a quorum was present with registered Member-Owners.

#### 2022 Minutes:

Attorney Hank Bailey asked for a motion to dispense with the reading of the minutes from the 2022 Annual Meeting of the Membership. A Member-Owner from the floor motioned to approve the minutes. The motion was seconded and approved without dissent.

Joint Report by President Jim Rogers and General Manager Russell Waldner:

President Rogers and Mr. Waldner reported their written report was in the WREN and encouraged the membership to read it. Mr. Parrie completed a slide show that entailed pictures of Carbon's new substations.

#### **Treasurers Report:**

Treasurer Daniel Hodgkiss reported on the taxes paid by Carbon in 2021. Mr. Hodgkiss reported the annual audit would be taking place in July by Blodgett, Mickelsen & Adamson P.S. and that last year's audit results concluded no issues.

#### **Student Scholarships:**

Scholarship certificates were presented to the 2020-2021 scholarship recipients. Carbon's recipients were Geoffrey Johnson, Gage Schlager, Michael G. Anderson. Tri-State recipents were Kyle Nuhn and Koye Gilbert. Basin recipient was Edward Buford.

#### Service Awards:

President Jim Rogers and Mr. Waldner presented certificate of service to the employee; Mr. Perry Davidson for 25 years. Mr. Waldner presented the certificate of service on the Board to President Jim Rogers for 10 years and for 15 years of service to Director Dick Clifton.

#### Tri-State Report:

Carbon's Board representative for Tri-State for 2021, Director Clay Thompson, reviewed Tri-State's operations over that year. Director Thompson engaged the crowd into telling him what the most important item to them was. Affordability, Reliability, Flexibility and Responsibility. Reliability won easily.

Director Thompson introduced the Chief Energy Innovations Officer for Tri-State, Mr. Reg Rudolph. Mr. Rudolph reported on the Valentine's Day cold snap in 2021. Mr. Rudolph stated he would do his best to keep reliable and affordable energy for Carbon's members.

#### **Election Results:**

#### **New Business:**




#### Adjournment:


